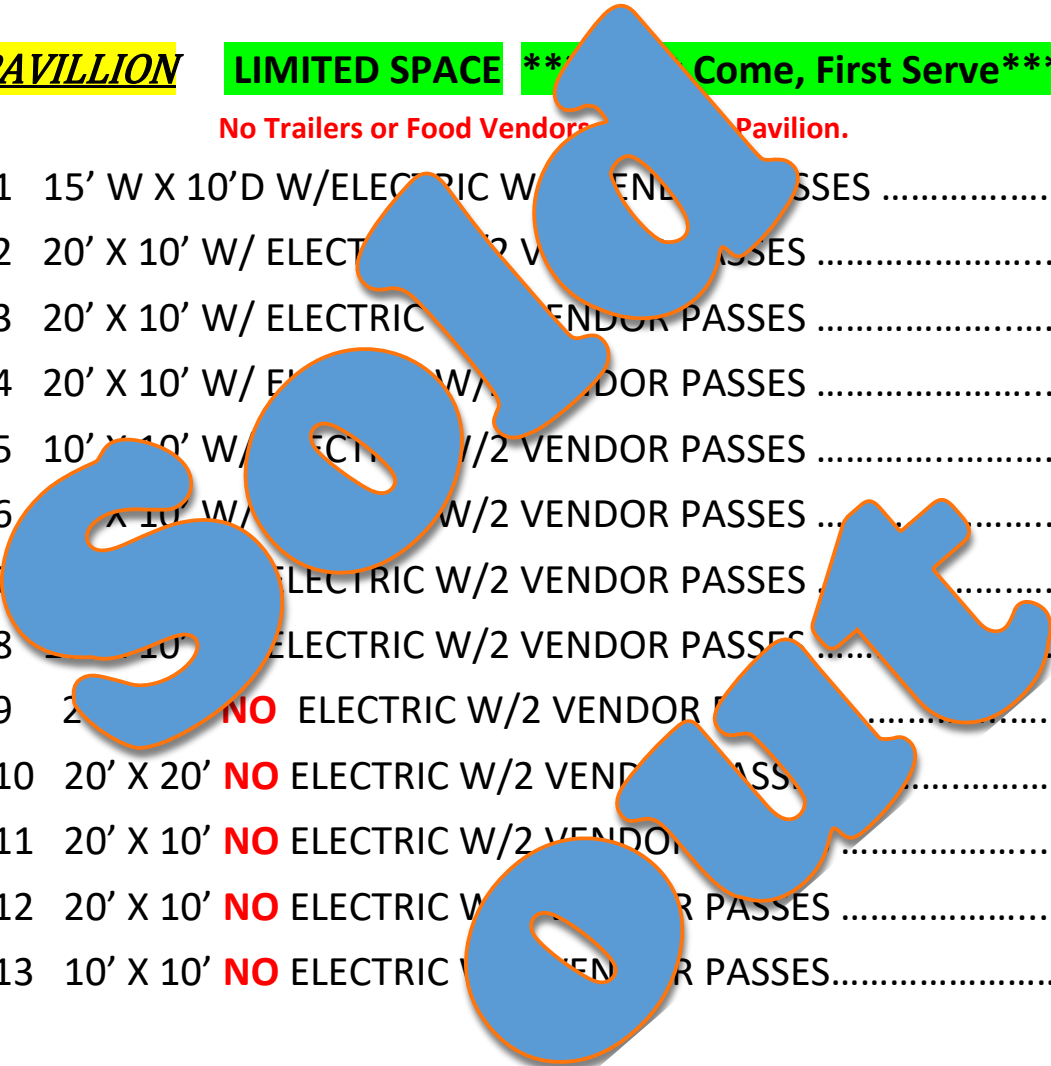

RAIN OR SHINE...NO REFUNDS

LUMBERTON Trade Days is sponsored by the Lumberton Chamber of Commerce (consisting of business members that are volunteers and one staff person) and the City of Lumberton. Please abide by the following rules during your stay.

- Report to the chamber booth to check in immediately upon your arrival and before you begin set up.**
Each vendor MUST have a current application on file for the date of the event as required by our insurance company.
- The Chamber & City does not supply tables, chairs, coverings, extension cords, etc. nor do they help with the set up or tear-down of any booth.
- The total length of your trailer, including the tongue, cannot exceed the size of the booth you rent. If the complete trailer length exceeds the size booth you rented, you will be charged for an additional booth space.
- Each vendor will receive vendor parking passes as stated above.** Your pass must be visible on the windshield of your vehicle or it can be towed away at your expense.
- No food vendors** will be allowed under the pavilion. The **only exception** would be PRE-PACKAGED food vendors.
- No pets of any kind are allowed in vendor area at any time for sanitary reasons unless a service animal with documentation.
- NO GENERATORS ALLOWED** inside booths that purchase non-electrical booth space unless approved by Lumberton Chamber of Commerce.
- Disposing of grease with wastewater is prohibited.
- The following items are not allowed to be sold: foul smelling novelties, items that can be used as drug paraphernalia, knives that are considered illegal (spring loaded, double edged, excessive length, etc.), The selling of these items will result in the immediate dismantle of your booth without a refund of any kind and vendor will be subject to arrest.

10. **All booth spaces are available on a first come, first serve basis. In order to reserve a booth space(s), a completed application and the fee must be paid in full at the time of submission.**
11. No political booths will be allowed at Trade Days.
12. No exotic animal booths will be allowed at Trade Days.
13. There will be a charge of \$40.00 on any returned checks.
14. There will be **NO refunds after February 1, 2025** for any reason including weather conditions. Absolutely no exceptions will be made.
15. The Chamber and City are not responsible for any duplication in the type of food or craft items which might be sold in the different booths.
16. **No vehicles are allowed on the grounds during Trade Day hours. Set up or break down during Trade Days hours can continue by carrying your products in and out to the parking area. For the safety of the guests and other vendors this rule will be enforced.**
17. You are not allowed to giveaway free samples out in the walk-way in front of your booth. You may do so within your booth space.
18. You are not allowed to walk around the fairgrounds seeking donations. You must remain in your booth and solicit donations ONLY INSIDE your booth area.
19. **The Lumberton Chamber of Commerce and the City of Lumberton will not be held responsible for any of your lost or stolen property AND/OR damage done to your property. We do offer security overnight BUT we are still NOT responsible for any damage to your property.**
20. The Lumberton Chamber of Commerce & City of Lumberton reserves the right to refuse service to any one at any time.
